PRESIDENT'S ANNUAL REPORT FOR SEASON 2013















It is an ideal opportunity to reflect once again on the generosity of our many hundreds of volunteers who contribute many 1000's of hours each season.

In particular, our age coordinators are truly the glue that binds the Club together so a special thank you to everyone who has ever taken on that responsibility.

History of the Club deepends

What has been an ongoing mystery to the current committee is the lack of history of the club and exactly which year we were established. Recently, however, Pam Clifford – a local Northbridge resident and historian – when undertaking research for a book on Northbridge - unearthed a references to what we believe was the year of establishment of the Club in 1946 with sponsorship by the Volunteer Defence Corps.

The following extract was written by Pam and sent to the Club.

The Northbridge Football Club is one of the largest soccer clubs in NSW, but it was not always so. As far as can be ascertained, soccer was first played in Northbridge in the mid 1940s. In 1946 The University of Sydney Department of Social Studies conducted a survey entitled "A study of aspects of social organisation in the Municipality of Willoughby" and wrote about soccer in Northbridge:

Northbridge Junior Soccer Club President - T E Daniel

Sponsored by VDC Association of NB

Previously, the earliest date the Club could reference was a date about 1952. Mr Ron Hall, a postman from Cremorne who previously had worked in the coalfields in the Cessnock area, and was looking for a less stressful life, moved to the area ad started up the club.

The Club scoreboard is named in honour of Ron Hall so he clearly must have had a significant influence of the Club in its early years even if it had been operating for a few years already.

Based on this new date the Clubs is celebrating its 68th year in 2014.

Vale Pat Reilly

There are many people that the Club interacts with during the year, however, we would like to make a special mention of Pat Reilly – our long standing Mayor of Willoughby who passed away recently.

In recent years Pat made a number of decisions, which have had a major influence on the Club and have benefitted football immensely.

Importantly, Pat wholeheartedly embraced the Club's research in 2005 as well as our subsequent initiatives regarding Small Sided Games and ensured the Bales Park field layout was amended to suit our needs for season 2006 and beyond.

Furthermore, Pat firmly supported the decision to install the artificial grass surface at Northbridge Oval, which is enjoyed by Club members of all ages and levels of competition.

The Best of Both Worlds

It continues to give the writer great satisfaction that the Club has successfully managed to maintain and grow our very strong community football programmes and then very successfully provide a genuine local pathway for our player through the introduction of our Academy programmes and by entering teams in Football

With regard to our high performance programme in 2013 the Club set new enchmarks again.

Mens State League - Premiers and Club Champions

Firstly our Senior Men's team were premiers of the State League Mens 1 competition (the 3rd division of FNSW competitions) and our combined u16,u18, u20 and Mens squad were Club Champions.

Ordinarily this would have meant the Club would have been promoted to the National Premier League Mens 2 competition meaning the Club would have been eligible to field teams from u9 upwards in Football NSW competitions.

Unfortunately, for reasons only known to FNSW there was no promotion / relegation in respect of season 2014

Womens Premier League Teams - 4th in Club Championship

In what was another fantastic achievement by our National Premier Leagues Womens 1 teams placed 4th overall in the Club Championship against Clubs who have been playing in these competitions for many many years.

TECHNIQUE, TECHNIQUE, TECHNIQUE

We must continue to focus on quality at training - that is, continuing to improve each players technique by ensuring that at every training the children touch the ball at least 1000 times.

In regard to the development of players technical skills we re-iterate the recent research by Football Federation Australia identified that the 4 areas the kids need to focus on are as follows;

- 1st Touch
- Striking the ball (passing)
- Running with the ball
 - 1v1

These are the areas we are focussing on and the introduction of the circuit training programme for our youngest players ensures that we can build a solid foundation with the children. However, training once a week is not enough to properly develop these vital skills and a major goal must be for all our juniors from u7 and above to train at least 2 x week.

VISION STATEMENT

Our vision for Northbridge Football Club is to be recognised as a model Football Federation of Australia football club, building the future through youth development and community connection.

ULTIMATE OBJECTIVES

To play a leading role in youth development in Australian football through assisting our players to develop skills, technique and game awareness so they have the ability to achieve their full potential and ultimately providing a pathway to representative football in Australia in either the Socceroos or Matildas teams.

PUTTING TRAINING IN GAMES - CLUB STYLE OF PLAY

It is very pleasing to see the change in the way all our teams play and how the sport is rapidly embracing possession based football concepts. Our Northbridge FC style of play is summarised as follows:

- 1. Always encourages passing of the football as opposed to kicking it long;
- 2. Begins play from the defence, who are encouraged to start our attacks;
- 3. Uses a short passing game, with longer passes only when appropriate and as the exception rather than the rule;
- 4. Encourage technique and skill and rewards these throughout our Club;
- 5. Play attacking, entertaining football;



Notes to the Financial Statements for the year ended 31 December 2013

Note 1: Statement of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (NSW) 2009. The committee has determined that the Northbridge Football Club Inc is not a reporting entity.

The financial report has been prepared in accordance with the requirements of the Association Incorporation Act (NSW) 2009 and the following Australian Accounting Standards:

AASB 1031 Materiality

AASB 110 Events after the Reporting Period

No other applicable Accounting Standards, Urgent Issues Group Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this report.

(a) Income Tax

In accordance with Section 50-5 of the Income Tax Assessment Act 1997, the income of Northbridge Football Club Inc is exempt from income tax.

(b) Goods and Services Tax

Revenues, expenses and assets are recognised net of Goods and Services Tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payables in the balance sheet are shown inclusive of GST.

(c) Comparative figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.





(d) Going Concern

The accounts are prepared on a going concern basis.

Notes to the Financial Statements for the year ended 31 December 2013

(e) Equipment

Equipment is capitalised at cost in circumstances where there is the expectation that the future benefit of the equipment will extend over at least two accounting periods. Plant and equipment have been depreciated on the basis of the estimated useful life and the assessment of impairment.

(f) Inventory

Inventory is recorded at the lower of cost or net realisable value. Inventory was subject to full stock-take at 31 December 2013.

(g) Revenue

Registration revenue includes the registrations paid by each player.

Commission revenue includes revenue from equipment and clothing sales, photography commission, Skill Series rebates and mobile vendor commissions.

(h) Contingent liabilities

Contingent liabilities are brought to account in situations where there is a reasonable expectation that a future liability will eventuate and that it is prudent to bring such contingency to account in preparation for future payment or expenditure.
